Greetings from Transport for Christ!

Thank you for your support of TFC! We can set up your donation to be withdrawn automatically one time each month from your checking or savings account. This is completely safe, secure, convenient and easy!

Enclosed you'll find a Direct Payment Authorization Form. When you have completed the information, simply attach a voided check from the bank account you wish for us to contact for this purpose. Then mail the form and the voided check to us using the enclosed envelope and we'll initiate the process.

Our bank will contact your account with a pre-note when the set up process is completed. Your donation will not be removed from your account at that time; however this action will insure that the submitted information is correct. We are required to allow the bank up to 14 days for this part of the process; therefore your first donation will not be processed until after that time. On the second contact, your donation will actually be processed.

EFTs will take place on a weekly basis during the month as follows: 1st Wednesday and 2nd Wednesday. We will not be able to alternate your week each time, therefore, please select the week that will be consistently the best for you. Please indicate on item C next to TFC Contact Name where your donation is to be applied, example: General Fund, Chaplain Name/Chapel Name etc.

Should you wish to alter your giving in any way in the future, please don't hesitate to contact us. It's donors like you who enable this ministry to reach truckers with the Good News of the Gospel and God's love.
